**Ingestion**

- water before removing it, or wear gloves. Continue to rinse for at least 10 minutes. Chemical burns must be treated promptly by a physician. Wash clothing before reuse. Clean shoes thoroughly before reuse.

- Appropriate engineering controls** : Use only with adequate ventilation.
